SECTION 1 - PARENT / GUARDIAN DECLARATION AND CONTRACT OF ENROLMENT

GENERAL INDEMNITY.

- 5.3. A Google drive account is needed to scan and upload all documents such as assessments and exams.
- 5.4. Facilitator must be responsible to invigilate during examinations to avoid any misdemeanor.

PAYMENT OF FEES

- 6.1 Fees are payable annual amount as per fee structure.
- 6.2 Non-payment of fees will result in de-registration of learner.
- 6.3 In the event of a Third-Party taking responsibility for the payment of fees, the parent/s signature here to binds him/her jointly and severally in their personal capacity as surety and co-Principal debtor, with the Third Party for payment to Habtech of ay amounts which are owing and may at any time become owing to HC by the Third party.

TERMINATION AND CANCELLATION

- 7.1 The parent/s have the right to cancel this contract at any time, for any reason, provided a full term's notice in writing of the intention is submitted, before the withdrawal of the student from HABTECH, no course content refund will be applicable, if any course content amount is outstanding after the term the full amount becomes due
- 7.2 Habtech has the right to cancel this contract at any time, for any reason, provided that a full term's notice is given in writing of the decision to terminate this contract. At the end of the term in question, the student will be required to be withdrawn from Habtech.
- 7.3 Habtech may cancel this contract immediately and has no obligation to return any prepaid fees, if the parent/s are in material breach of any of their obligations, and have not (in the case of a breach which is capable of remedy) remedied the material breach within 20 (twenty) business days or a notice from Habtech requiring the parent/s to remedy the breach, and in addition it may claim payment of all monies then owing and damages equal to one term's fees (as calculated at the time of cancellation), taking into account the nature of the services, capacity planning and reasonable potential to fill the vacancy.

CURRICULUM FEE POLICY

Amounts payable

- 1. Course content fees payable in advance annually
- 2. Grade 10-12 Consumer Studies, Drama, hospitality and Visual Art and Design fee for cost of practical lessons and art supplies are separate.

Overdue fees

If any fee is not paid on the due date, the whole balance of the outstanding fee will immediately become due and payable.

The process for overdue fees is as follows:

- 1. Parents/Guardians whose fees are not paid within 7 days of the due date will receive a minimum of two notifications by SMS, email, phone call or direct conversation to remind them about payment/s.
- 2. When fees are not settled within one month of due date, parents/guardians will be contacted advising that a confidential letter addressed to the parents/guardian will be sent home with the student. The letter will state that the student may not return to school until the account is paid in full.
- 3. A letter may be sent to parents at the end of a school term, stating that the student will not be permitted to return to school the following term until the outstanding account is paid in full.

Special Financial Circumstances

<u>Before fees become overdue</u>, parents with special financial circumstances may notify the office in writing and must provide the following:

- 1 A detailed explanation of the circumstances.
- 2 A detailed plan of action to remedy the situation and maintain payment of the current fees.
- 3 Copies of the last three month's bank statement of BOTH parents.

Only then will this be considered by the financial committee and a decision will be conveyed to the parents in writing by the Principal.

Maintenance or other legal agreements between parents are a private matter. Habtech requires the signature ofboth parents/guardians acknowledging that parents/ guardians are jointly and severally liable for fees.
